

DIRECTIVE FROM THE COURT OF QUEEN'S BENCH

Due to COVID-19 and in an effort to limit in person contact in the Court houses across the Province, in person contact with each Clerk's office and the Queen's Bench section of the Registrar's office will only be made by appointment by contacting the appropriate office. Telephone and email access remain in effect during regular office hours but with reduced staff.

JUDICIAL DISTRICTS

The filing of documents will be accepted in the Court of Queen's Bench (Trial Division and Family Division) and Small Claims Court, by mail, courier, fax, electronic filing by email, or by leaving the documents in a secure box set out for that purpose and located in a designated place in each Court House. For electronic filing by email, please refer to the email addresses listed below for each Judicial District.

Filing of documents in the Probate Court will only be accepted by mail, courier or by leaving the documents in a secure box set out for that purpose and located in a designated place in each Court House.

Payment of filing fees for e-filing or filing by fax may be made by credit card by calling the telephone number of the Judicial Districts listed below.

REGISTRAR'S OFFICE

Filing of Petitions/Applications for Divorce and Answer and Counter-Petitions will only be accepted for filing by mail, courier or by leaving the documents in the secure box set out for that purpose located outside Room 202 in the Justice Building in Fredericton. Filing fees (certified cheque or money order) must be included. All other documents for the Divorce Registry may be filed via e-mail at the address mentioned below.

Bankruptcy documents can be filed by mail, courier, fax, electronic filing by email, or by leaving the documents in the secure box set out for that purpose located outside Room 202 in the Justice Building in Fredericton. Filing fees for bankruptcy documents must still be sent by cheque.

Please note that processing of court documents may take longer than usual considering that we are presently operating with a reduced staff.

This directive is effective immediately and until further notice.
